1. CALL TO ORDER AND DECLARATION OF CONFLICT

The Mayor called the Regular Council Meeting to order at 7:03 p.m. and asked for any declarations of Conflict of Interest.

3. APPOINTMENTS AND DELEGATIONS

3.1 <u>Cameron Reid and Randy Joe, Syiyaya Reconciliation Movement</u>

Mr. Reid addressed Council regarding their support in the Reconciliation Movement. He stated that now that they have Council's support, they need dollars. Since the launch of their project they have been fundraising but need more money. Mr. Reid informed Council that he is not asking for money from the tax payers but rather to receive money from the reserve funds of the Community Forest. To date, they have already received \$30,000 from the Community Forest operating fund. He believes in building the community through reconciliation. Mr. Reid would like Council to open an account and recognize reconciliation as a significant project and opportunity.

Mr. Joe, a member of the shíshálh First Nation, stated that the Reconciliation Movement is very important to him and the Nation. He commented that they have been fundraising and things are going well but they are a long way away from their goals. Mr. Joe stated that the shíshálh First Nation has been struggling with reconciliation efforts for the past 150 years. He has heard many stories about shíshálh First Nation's history from his

family. He commented that the Reconciliation Movement is spreading across Canada and is gaining momentum. He feels it is time for change and to tear down the walls around the reserves. He stated that the Nation needs the District's support. The Reconciliation Movement has been very challenging and with little success to date. His family has been in politics for the past 150 years. Mr. Joe wants Council to open their hearts and wallets to support the movement.

Mr. Reid explained that their organization is currently doing a lot of planning to launch the first exercise which consists of weaving blankets in August. They plan to weave four blankets, one of which could be hung in the Municipal Hall. Mr. Reid is concerned that they may stall due to lack of funds. They are looking for support from the District as well as others. They have the ball rolling and a large part of the community is on board. Mr. Reid commented that he hopes the reconciliation efforts do not become a failed attempt due to lack of funding.

Mr. Joe stated that their organization has been holding numerous meetings where they have come up with great ideas. Chief and Council have been in attendance at their meetings and are showing their full support.

Mr. Reid explained that they have run into some hurdles for not being a fully Indigenous staffed organization. To date they have raised \$37,000 out of their \$190,000 goal. Because they are not a charitable organization they are not always eligible to apply for grant funding. Mr. Reid informed Council that individuals can donate money by contacting the steering committee and that the District will issue a tax receipt for donations.

Mr. Reid said they have approached the SCRD, SIGD, Community Foundation, Vancouver Foundation and various banks for funding. A lot of the funding cycles are at certain periods and are not available until next January. They want to get started on their projects as soon as possible.

The Mayor thanked Mr. Reid and Mr. Joe for their presentation.

11.1 Reports from Councillors

Councillor Shanks has listened to issues being raised at the mobile home park in Wilson Creek in regards to the transfer of garbage disposal and recycling. Residents are concerned about how it will affect next year's taxes. He would like to set a date for a discussion on how to mitigate the impacts from the development.

Councillor Lutes attended one of the world cafés on the Community Forest. She noted the event was well attended and she heard a lot of different views. She also attended some meetings with the Community Associations and Council.

Councillor Muller has been busy with the regularly scheduled meetings as well as other meetings. He went to the World Café for the Community Forest and was impressed with turnout and the different views that were expressed. He observed that some of the conversations at the discussion tables were more middle ground instead of the activists commenting on their views. The event had a good tone which the Communications Manager helped to set. Councillor Muller also met with the Community Associations and had a great meeting. He attended an Oktoberfest planning meeting and will help host the event again this year with the Sechelt Downtown Business Association. He found some time to sit down and have coffee with the Mayor where they discussed the next four years. Councillor Muller is going away on vacation in the upcoming weeks to reflect on his future plans.

Councillor Siegers briefly attended the Catch a Trout Day at Chapman Creek Hatchery. It was an interesting event with lots of kids present. She also attended a Canada Day

review meeting. She commented that while we did not have quite enough volunteers, those who assisted put in such a huge effort that the event was still a success and came together really well. Councillor Siegers thanked District staff for their immense amount of support before, during and after the event. At the meeting, they discussed what can be done for next year to fine tune the Canada Day celebration. One issue that came during the event were the horses and the Councillor Siegers recognized Kim Mann for her efforts in taking on the contract with the District of Sechelt to organize Hackett Park for the event. It was amazing how she brought it all together and kept it running past 4:00pm. Councillor Siegers also attended the Self Employed Women's Network Meet-up, which has been revitalized and is being held in Sechelt. She commented that there were women from all over the Coast attending the meeting. It was nice to see the group reunite and support each other. Last evening, Councillor Siegers attended the Community Association meeting.

Councillor Wright read an ode to a four year term as a District of Sechelt Councillor.
