

DISTRICT OF SEHELDT

BYLAW NO. 504-1, 2018

A bylaw to amend certain procedures for the conduct of
local government elections and other voting

WHEREAS Council of the District of Sechelt adopted District of Sechelt Elections and Other Voting Bylaw No. 504, 2011;

AND WHEREAS Council wishes to add a procedure for providing public access to nomination documents delivered to the chief election officer and make other housekeeping amendments;

NOW THEREFORE, the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

1. TITLE

This Bylaw may be cited for all purposes as “District of Sechelt Elections and Other Voting Amendment Bylaw No. 504-1, 2018”.

2. AMENDMENTS

- (a) The following section 2 is hereby added to Bylaw No. 504, 2011, and the remaining sections in the bylaw are renumbered in sequential order:

“2. Access to Nomination and Endorsement Documents

As authorized under the *Local Government Act*, public access to nomination documents required under the *Act* will be provided by making copies available at the District of Sechelt offices during regular office hours on request of any person and by posting on the District’s website from the time of delivery of any nomination documents to the Chief Election Officer until 30 days after the declaration of the election results.

- (b) Section 3(a)(i) - Advance Voting Opportunities, of Bylaw No. 504, 2011 is hereby deleted and replaced with:

“(i) the fourth (4th) day before general voting day”.

 - (iii) Sechelt / shíshálh Hospital

- (k) Section 5(e)(i)(c) – Mail Ballot acceptance or rejection, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 55” and replacing with “section 70”;
- (l) Section 5(e)(vi)(b) – Mail Ballot acceptance or rejection, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 55” and replacing with “section 70”;
- (m) Section 5(e)(vii) – Mail Ballot acceptance or rejection, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 150(6)” and replacing with “section 150(8)”;
- (n) Section 5(f)(i) – Mail Ballot challenge of elector, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 116” and replacing with “section 126”;
- (o) Section 5(f)(ii) – Mail Ballot challenge of elector, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 116” and replacing with “section 126(2) to (5)”;
- (p) Section 5(g)(i) – Mail Ballot electors name already used, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 117” and replacing with “section 127”;

- (q) Section 5 – Resolution of the Vote After Judicial Recount, of Bylaw No. 504, 2011, is hereby amended by deleting the text, “section 141” and replacing with “section 151”;
