

DISTRICT OF SEHELDT

BYLAW NO. 504-2, 2022

A bylaw to amend certain procedures for the conduct of  
local government elections and other voting

---

WHEREAS Council of the District of Sechelt adopted District of Sechelt Elections and Other Voting Bylaw No. 504, 2011;

AND WHEREAS Council deems it appropriate to amend mail ballot provisions and make certain housekeeping amendments to Bylaw No. 504, 2011;

NOW THEREFORE, the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

1. TITLE

This Bylaw may be cited for all purposes as "District of Sechelt Elections and Other Voting Amendment Bylaw No. 504-2, 2022".

2. AMENDMENTS

(a) Section 6 (a) – Mail Ballot Voting, of Bylaw No. 504, 2011 is deleted and replaced with the following:

"As authorized under section 110 of the *Local Government Act*, voting may be done by mail ballot and registration of electors may be done by mail in conjunction with mail ballot voting."

(b) Section 6 (b) – Mail Ballot Voting, of Bylaw No. 504, 2011 is deleted in its entirety and the remaining sections in the bylaw are renumbered in sequential order.

(c) Section 6 (b)(ii) – Mail Ballot Voting, of Bylaw No. 504, 2011 is deleted and replaced with the following:

" (ii) Upon receipt of a request for a mail ballot, the chief election officer or designate shall, no later than 12 days before general voting day and up to 4:00 pm on the Thursday two days before general voting day, make available to the applicant, a mail ballot package as specified in section 110(7) of the *Local Government Act*,

and immediately record and, upon request, make available for inspection the name and address of the person to whom the mail ballot package was issued."

- (d) Section (6)(e)(i) – Mail Ballot Voting is amended by deleting the text, "Section 5(f)" and replacing with, "section 6(f)".
- (e) Section (6)(e)(iv) – Mail Ballot Voting is amended by deleting the text, "Section 5(e)" and replacing with, "section 6(e)".
- (f) Section (6)(e)(vii) – Mail Ballot Voting is amended by deleting the text, "Section 5(e)(vi)" and replacing with, "section 6(e)(vi)"; and by deleting the text, "Section 150(8)" and replacing with, "Section 160".
- (g) Section (6)(h)(ii) – Mail Ballot Voting is amended by deleting the text, "Section 5(c)(ii)" and replacing with, "section 6(c)(ii)".
