

**DISTRICT OF SEHELDT
BYLAW NO. 515-13, 2023**

A Bylaw to amend the District of Sechelt Bylaw Notice Enforcement
Implementation Bylaw No. 515, 2012

WHEREAS the Council of the District of Sechelt has adopted Bylaw Enforcement Implementation Bylaw No. 515, 2012;

AND WHEREAS the Council of the District of Sechelt deems it desirable to amend the Zoning Bylaw section of Schedule A of Bylaw No. 515, 2012;

NOW THEREFORE, the Council of the District of Sechelt in open meeting assembled enacts as follows:

TITLE

1. This bylaw may be cited for all purposes as, "District of Sechelt Bylaw Notice Enforcement Implementation Amendment Bylaw No. 515-13, 2023".

AMENDMENTS

2. District of Sechelt Bylaw Notice Enforcement Implementation Bylaw No. 515, 2012 is hereby amended by removing all references to "Dog Licensing and Control Bylaw No. 221, 1994" within Schedule "A" and replacing with the references in Attachment A that forms part of this bylaw :

PROVISIONS

3. If any section, subsection or clause of this bylaw is for any reason held to be invalid by the decision of a court of competent jurisdiction, such decision will not affect the validity of the remaining portions of this bylaw.
