**Bylaw No. 491-05, 2025**

A bylaw to amend the Municipal Ticket Information Bylaw No. 491, 2010 for the District of  
Sechelt

---

**WHEREAS** Section 260(1) of the *Community Charter* authorizes the Council of the District of Sechelt to enact bylaws for the purposes of enforcing bylaws of the municipality;

**AND WHEREAS** Section 264(1)(a) of the *Community Charter* authorizes the Council of the District of Sechelt to designate a bylaw for the purposes of this section other than a bylaw in relation to a matter prescribed by regulation;

**AND WHEREAS** the Council of the District of Sechelt deems it expedient to authorize the use of Municipal Ticket Information for the enforcement of certain bylaws, designate certain bylaw offences and set certain fine amounts;

**NOW THEREFORE**, the Council of the District of Sechelt in open meeting assembled enacts as follows:

**TITLE**

1. This bylaw may be cited for all purposes as, "Municipal Ticket Information Amendment Bylaw No. 491-05, 2025".

#### PROVISIONS


